

Minutes from the Town of Trenton Special Town Board Meeting

Date and Time: March 30, 2010 – 7:30 P.M.

Place: Town of Trenton Town Hall, 1071 Highway 33 East, West Bend, WI 53095

Present: Chairman Joe Gonnering, Supervisor John Norman, Town Clerk Barbara Davies. Excused: Supervisor Ed Doerr.

Chairman Gonnering called the Meeting to order at 7:30 PM.

Pledge of Allegiance:

Chairman Gonnering invited all in attendance to join in saying the pledge of allegiance prior to the meeting.

Approval of Minutes: None.

Affidavit of Posting:

Chairman Joe Gonnering read the affidavit of posting, and stated that the Agenda for tonight's meeting had been posted as required and an affidavit of posting has been filed.

Comments and Questions from the Audience:

Darryl Zellmer asked why Kevin Juech has been permitted to keep adding to a large dirt pile on Wallace Lake Road. Chairman Gonnering told Zellmer that Juech had obtained the proper permits to allow him to have the dirt pile there. Zellmer then said he wanted to file a complaint about the pile of salt that Juech is "hiding" behind his garage. Gonnering will turn the complaint over to Frank Mayer.

Both bidders were furnished with a copy of the Town's prevailing wage determination for the project. Gonnering read the bid amounts aloud, including quantities and prices. Gonnering stated that there would be no bid award this evening, and asked Town employee Jim Wollner to review the bid amounts and prepare a report for the 4/5/10 Town Board meeting.
