

Minutes from the Town of Trenton Town Board Meeting

Date and Time: Tuesday, May 4, 2010 – 7:30 P.M.

Chairman Gonnering called the Meeting to order at 7:32 P.M.

Pledge of Allegiance: Chairman Gonnering invited the citizens in attendance to join in saying the Pledge of Allegiance.

It was moved by John Norman and seconded by Ed Doerr to approve the Minutes of the Town Board Meeting of April 20, 2010. Voting aye: 3. Nay: 0.

Affidavit of Posting:

Chairman Gonnering read the affidavit of posting, stating that prior to the Meeting, notice was properly posted on the Town Bulletin Boards and mailed to the West Bend Daily News and WBKV AM/FM.

Comments and Questions from the Audience:

Bob Reischl, a resident on Eastwood Trail, asked if there were any plans to work on Trenton Road from Highway 33 to Creek Road. Chairman Gonnering explained that that section of Trenton Road is now the responsibility of the City of West Bend. Discussion followed.

Accept/Review Agenda:

It was moved by John Norman and seconded by Ed Doerr to approve the Agenda as presented. Voting aye: 3. Nay: 0.

Approval of 2010 Contract, West Bend Youth Football League (Tabled 4/20/10):

It was moved by John Norman and seconded by Ed Doerr to approve the contract with the West Bend Youth Football League for 2010. Voting aye: 3. Nay: 0. The contract is approved with an effective date of June 1 to avoid a late summer approval process just before the teams begin play. Watering of the fields was discussed.

JT Roofing, Revision of South Oak Road Certified Survey Map (Tabled 4/20/10):

No hard copy of the map has been received. It was moved by Ed Doerr and seconded by John Norman to table action to the Town Board Meeting of 5/18/10. Voting aye: 3. Nay: 0.

Cindy Komro had nothing to report.

Monica Diaz reported receipt of the fuel tax refund in the amount of \$275.63. Use of personal cell phones to make or receive town business calls was discussed.

Barb Davies reported that Representative Pat Strachota has asked to address the Board at the 5/18/10 meeting; West Bend Lakes is not doing its own dandelion/weed spraying this year; notice has been received of a 6/3/10 seminar being offered by the County on various Comprehensive Plan issues. Chairman Gonnering plans to attend that meeting.

Chairman Gonnering asked that the Board plan to pick the roads to surface this summer at the 5/18 Town Board meeting. Discussion followed.

Supervisor Ed Doerr reported that the poison ivy is starting to come up. Doerr would like to talk to the Plan Commission re: the dirt piles during construction projects; and the use of dumpsters during building projects. Doerr stated that he would like to see a requirement for removal of both the dirt and the dumpsters within a defined period of time. Discussion followed. Doerr would like to see a requirement for completion of rough grading after the foundation is capped, followed by removal of any remaining "leftover" dirt following grading.

Supervisor John Norman reported that he has not received many town phone calls in the past two weeks. Norman may need to miss the 5/18/10 meeting.

#### Payment of Bills:

It was moved by Ed Doerr and seconded by John Norman to approve payment of bills totaling \$36,755.82, and payroll totaling \$14,947.74. Voting aye: 3. Nay: 0.

#### Other Business:

Ed Doerr asked if there might be any value to go to every other week for recycling pickup. Joe Gonnering said that issue would have to be discussed at Veolia's contract renewal. Cindy Komro and Monica Diaz both reported a large quantity of recyclables placed out for collection every week.
