

Minutes from the Town of Trenton Public Budget Hearing

Chairman Gonnering called the Public Budget Hearing to order at 7:05 P.M.

Gonnering read the Notice of Public Budget Hearing called to consider the Proposed 2012 Budget for the Town of Trenton. Gonnering discussed actual 2011 expenditures compared to the 2012 Proposed Budget. The proposed 2011 tax levy, to be collected in 2012, is \$936,147.00.

Gonnering asked for any questions or comments.

Elector Dennis Kay commented on the amounts for Public Charges for Services. Deputy Clerk Barbara Davies explained that the Town must recover the 2011 unbudgeted garbage collection fuel surcharge (nearly \$45,000). Kay also commented on the Public Works number. Davies explained that the increase is attributed to additional allocations by the Board. Elector Michael Bykowski asked for clarification of the Police Department Budget. Davies summarized the Police income and expenditures.

Gonnering closed the Public Budget Hearing at 7:15 PM.

Approval of highway expenditures for 2012 pursuant to Wis. Stats. Sec. 82.03(3):


